Each RSU was the economic equivalent of one share of California Resources Corporation (CRC) common stock. On February 20, 2019, 3,054 of the reporting person's RSUs were settled for cash, and the remaining 4,581 were settled for an equal number of shares of CRC common stock.
2. One-third of the RSUs vested on February 20, 2019; the remaining RSUs vest in two equal annual installments beginning February 20, 2020.
