4. Grant of RSUs pursuant to the California Resources Corporation Long-Term Incentive Plan. Upon vesting, the RSUs will be settled 50% in shares of common stock and 50% in cash.
5. The RSUs vest in three equal annual installments beginning February 17, 2021.
6. The options vest in three equal annual installments beginning February 17, 2021.
